THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, Rex. A. Heuermann, of the crime of **MURDER IN THE FIRST DEGREE**, in violation of New York State Penal Law Section 125.27(1)(a)(xi), committed as follows:

The defendant, Rex A. Heuermann, being more than 18 years of age at the time of the commission of the crime, on or about July 10, 2009, with the intent to cause the death of Melissa Barthelemy, caused the death of Melissa Barthelemy, and on or about December 11, 2010, the body of Melissa Barthelemy was found in the County of Suffolk; and as a part of separate criminal transactions within a period of twenty-four months, when committed in a similar fashion or pursuant to a common scheme or plan; the defendant, with the intent to cause the

death of Megan Waterman, caused the death of Megan Waterman on or about June 6, 2010, in the State of New York; and the defendant, with the intent to cause the death of Amber Costello, caused the death of Amber Costello on or about September 2, 2010, in the State of New York.

COUNT 2

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, Rex. A. Heuermann, of the crime of **MURDER IN THE FIRST DEGREE**, in violation of New York State Penal Law Section 125.27(1)(a)(xi), committed as follows:

The defendant, Rex A. Heuermann, being more than 18 years of age at the time of the commission of the crime, on or about June 6, 2010, with the intent to cause the death of Megan Waterman, caused the death of Megan Waterman, and on or about December 13, 2010, the body of Megan Waterman was found in the County of Suffolk; and as a part of separate criminal transactions within a period of twenty-four months, when committed in a similar fashion or pursuant to a common scheme or plan; the defendant, with the intent to cause the death of Melissa Barthelemy, caused the death of Melissa Barthelemy on or about July 10, 2009, in the State of New York; and the defendant, with the intent to cause the death of Amber Costello, caused the death of Amber Costello on or about September 2, 2010, in the State of New York.

COUNT 3

The defendant, Rex A. Heuermann, on or about July 9, 2007, with the intent to cause the death of Maureen Brainard-Barnes, caused the death of Maureen Brainard-Barnes, and on or about December 13, 2010, the body of Maureen Brainard-Barnes was found in the County of Suffolk.

COUNT 8

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, Rex. A. Heuermann, of the crime of **MURDER IN THE SECOND DEGREE**, in violation of New York State Penal Law Section 125.25(1), committed as follows:

The defendant, Rex A. Heuermann, on or about or between July 21, 2003, and July 26, 2003, with the intent to cause the death of Jessica Taylor, caused the death of Jessica Taylor, and on or about July 26, 2003, and on or about March 29, 2011, the body, or a part thereof, of Jessica Taylor was found in the County of Suffolk.

COUNT 9

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, Rex. A. Heuermann, of the crime of **MURDER IN THE SECOND DEGREE**, in violation of New York State Penal Law Section 125.25(1), committed as follows:




COUNT 10
